Add Alternate #2

The entire complex consists of six courts. The base is for the first five, Add Alternate #2 adds the 6th court which required the follow work: Provide all equipment, material, and labor to remove and replace 280 SQ. FT of AC; Let cure for ten (10) days. On 11th day, provide all equipment, material, and labor to repair and resurface one tennis courts at Piedmont Hills High School. Work shall include but not limited to: Clean and prep surface for repair work; clean out all cracks; Seal all cracks with court patch binder; Sand and prep all repaired areas before coating surface; Apply 3 coats of asphalt emulsion to courts; Apply 3 coats of full color acrylic, (color to be determine); Apply lines with USTA approved white line paint.
