# East Side Union High School District Seeks Applicants for Citizens' Bond Oversight Committee

The East Side Union High School District is recruiting applicants for the Citizens' Bond Oversight Committee (CBOC). Measures G, E and I were passed under the rules of Proposition 39, which directs the Board of Trustees to appoint a Citizens' Bond Oversight Committee to monitor bond expenditures. This Committee is responsible for reviewing expenditures related to the three general obligation bonds passed by voters: Measure G (\$298 million) approved by voters in March 2002, Measure E (\$349 million) approved by the voters in February 2008 and Measure I (\$120 million) approved by the voters in November 2012. Members serve two-year terms.

The current CBOC has 14 members. The terms of 7 of the members will expire on May 31, 2013. All of the members whose terms are expiring are eligible to re-apply.

No employee or official of the District can be appointed to the Citizens' Bond Oversight Committee. Also vendors, contractors, or consultants of the district are not allowed to serve as members of the Committee.

### EAST SIDE UNION HIGH SCHOOL DISTRICT APPLICATION FOR CITIZENS' BOND OVERSIGHT COMMITTEE

The Board of Trustees of the East Side Union High School District are seeking qualified, interested individuals to serve on a committee of community leaders, which will serve as the independent Citizens' Bond Oversight Committee ("CBOC") for the implementation of the District's Measure G, Measure E and Measure I Bond Programs.

#### **Proposition 39 Bond Election**

On March 5, 2002, voters residing within the East Side Union High School District passed Measure G, on February 5, 2008, voter residing within the ESUHSD passed Measure E and on November 6, 2012, voters residing within the ESUHSD passed Measure I. Measure G is a \$298 million general obligation bond, Measure E is a \$349 million general obligation bond measure and Measure I is a \$120 million general obligation bond measure which authorizes funding for needed repairs, upgrades, and new construction projects at the District. Proposition 39 requires a 55% supermajority for approval; Measure G was approved with a 69.9% vote, Measure E was approved with a 71.39% vote and Measure I was approved with a 71.55% vote.

#### **Establishment of a Citizens' Bond Oversight Committee**

After a bond authorized under Proposition 39 is passed, state law requires that the East Side Union High School District Board of Trustees appoint a Citizens' Bond Oversight Committee to work with the District.

#### **Committee Responsibilities**

In accordance with Education Code Section 15278(b), the Citizens' Bond Oversight Committee shall:

- Inform the public concerning the District's expenditure of Measure G, Measure E and Measure I Bond proceeds;
- Review expenditure reports produced by the District to ensure that Measure G, Measure E and Measure I Bond proceeds were appropriately expended;
- ➤ Present to the Board of Trustees, in public session, a quarterly and annual written report outlining their activities and conclusions regarding the expenditure of Measure G, Measure E and Measure I Bond proceeds.

#### **Appointment of Committee Members**

All appointments will be made by the Board of Trustees from applications submitted to the District.

#### **Time Commitment and Term**

Initial appointments will be staggered, such that some of the initial appointees will be appointed to serve one full two-year term. The other initial appointments will serve a one-year term, but will be eligible for reappointment by the Board of Trustees for a second two-year term.
