# 6.01 Discussion and/or Action regarding Superintendent's Employment Contract – J. Manuel Herrera, Board President

# Board President J. Manuel Herrera

The Board is taking action today to establish the policy framework for the Superintendent's new contract with the District excluding issues of compensation and fringe benefits, which we cannot take action on at a Special Board Meeting and will be carried forward to a regular meeting in December. I'll have General Counsel explain.

## Legal Counsel Rogelio Ruiz

With respect to Closed Session, there are no Closed Session actions to report.

With respect to item 6.01, Discussion and/or Action regarding the Superintendent's Employment Contract, before you is a draft of an employment agreement to reemploy the Superintendent for a term of three years, beginning July 1, 2019. His current contract expires on June 30, 2019; this would be subsequent to this contract. This contract, if approved by the Board, would only go into effect if the Superintendent's employment is in good standing and his current contract hasn't been terminated by the Board by Board action on or prior to June 30, 2019.

The draft you have in front of you is based on the Superintendent's existing contract, which was approved by this Board in 2015 and incorporates changes that were approved by the Board in connection with the Superintendent's first amendment and second amendment to his contract. This form of contract in front of you substantially follows that form, except that you will see I have redacted all provisions relating to salary, salary schedules in compensation, and any compensation in the form of fringe benefits because the Brown Act prohibits any discussion of those types of items in a Special Meeting.

In front of you is a redline compared to his existing 2015 contract, the recitals include new information relating to his existing contract in 2015. In section one of the prepared draft, you will see that it is for a term of three years, commencing July 1, 2019, through June 30, 2022. The contract does not go into effect unless his employment is in good standing. This draft also provides for the Board, in its discretion, to extend this contract for one more year, through June 30, 2023, provided that if the Board determines it will not be extending his contract, the Board would have to provide the Superintendent written notice of such determination not to renew or extend no later than November 30, 2021, and the Superintendent, as a condition that, would have to provide written notice delivered to all Board Members no later than August 31, 2021, of the Board's November 30, 2021, determination deadline not to renew, except as shown in this redline. All other provisions are substantially identical, except as shown in this redline and with the understanding that

all of the compensation terms have been blocked out. All of the other terms are substantially identical to the 2015 contract.
