
After many hours of debate, research and campus tours the following allocations were agreed upon. The list is based on the following:

Dear Alan,

At your request I am submitting this e mail to inform you that the school Measure G Committee met on Thursday, April 27 2006 to discuss Overfelt High School's Master Building Plan, budget, current projects and future projects. For the record, I want to inform you that the committee, in good faith, represents the "best interests" of the entire school community. The goal of this committee is to ensure that Overfelt High School receives its "fair share" within the constraints of the current budget, while making certain that there is equity among all stakeholders on campus.

We are indeed gratified that we are finally witnessing new construction and modernization. The two new classroom wings (22) are long overdue! These wings are scheduled to be completed by February, 2007 (15 months). The budget for this project has been estimated to be approximately \$13 million.

In order to maximize our budget, we are now ready to quickly begin the next phase of new construction- the Science building (10 classrooms and 4 lab stations) In our conversations with Mr. Wendell Vaughn, principal

architect for Perkins and Wills, all parties have come to the conclusion that the construction of the new Science wing is certainly feasible with the remaining funds. The current plan calls for the construction of building S & T (gain of 22 classrooms), the construction of a new Science wing (10 classrooms) that will be esthetically tied into the campus; (a gain of 32 new classrooms); the demolition of the C and B wings ( a loss of 32 classrooms). We will be losing 32 old, substandard classrooms and gaining 32 new "state of the art" classrooms.

Therefore, it is our recommendation at this time to proceed with the architectural planning and submission of these plans to DSA so as to take full advantage of the "buying power" of the remaining dollars in Measure G. We also are aware that current facilities will need attention. We will be prudent in the manner by which we allocate funds to maintain and improve current facilities. We are aware that the District will make available to Overfelt High School additional "matching" monies (\$8.5 million) from the state for modernization of remaining substandard classrooms and facilities. ( E wing, Art bldg., J wing, Administration, Library) when these funds become available.

I appreciate your efforts in ensuring that Overfelt High School is provided the needed resources and support to bring our facilities up to standard.
