All Collective Bargaining Agreements Ratified by the Board of Trustees

Dear Friends of ESUHSD,

The Board of Trustees at their Board Meeting of January 15, 2015, ratified the collective bargaining agreements for each of the bargaining units: East Side Teachers Association, California School Employees Association, American Federation of Teachers and Administrator Collaborative of East Side. We are excited about being able to provide our dedicated staff with a highly competitive and equitable, total compensation package.

The ratified agreements include a 5% on the schedule salary increase and up to an additional 1.5% on the schedule salary increase, which is contingent on the Legislature taking action increasing current year (2014-2015) Proposition 98 LCFF funding. This agreement continues to pay 100% of family medical insurance benefits, including 100% of life insurance, vision and dental benefits.

The Collective Bargaining Agreement with the East Side Teachers Association also includes: an increase to hourly rates used to pay for teachers' extra duty; stipends for advisors, counselors and other certificated positions outside of the classroom; and, an increase to the salary schedule for our children's center instructors.

In addition, the District is required to increase our contribution for certificated and classified employee pension benefits, effective July 1, 2014.

We appreciate the hard work and collaborative efforts on the part of all the bargaining teams. The District's goal is to provide its employees with a total compensation package, which includes salary and health and welfare benefits, which is competitive in Santa Clara County. We believe that our dedicated public employees deserve to be rewarded for their professionalism and the sacrifices made during the fiscal crisis that California faced since the last recession. ESUHSD is a destination to work and provide an outstanding education for every student.

Governor's Budget Outlook

The Governor recently released his proposed budget. Once again, his budget reflects the positive trend in the economy. The Governor is projecting increased revenues for the State. K-12 education will continue to receive most of the new money.

Although the Governor has earmarked additional funding for K-12 education in the current and future years and has proposed an increase to Adult Education and Career Technical Education, he has also moved forward with his mandate to address the STRS/PERS deficit.

As a result, the District is obligated to cover more of the costs for the employer portion of STRS/PERS. There is no new money in the proposed Governor's budget to meet this new requirement.

These dollars are subtracted from any new dollars the District is projected to receive. There are

efforts currently underway by education advocacy organizations to encourage the Governor and the Legislature to change the funding mechanism so that school districts are not impacted in this way. The District was counting on these funds to continue restoration efforts in relation to staffing, class size, programs, and salaries. It is clear that a loss of this proportion will take the momentum out of our efforts, unless the Governor decides to cover the costs without reducing our District's Local Control Funding.

Moving forward, our primary focus is to address class size. Class size impacts classroom management, teacher/student interaction, teacher preparation and teacher grading. Class size also impacts creativity and innovation that happens at all of our schools throughout the District.

Class size reduction is the single most expensive priority that we must address. We need the Governor and the Legislature to solve the STRS/PERS funding issue in order for us to aggressively tackle class size reduction.

Of course, this is just the first salvo and there will be much negotiating and compromising between the Governor and the Legislature until a final budget agreement is reached in June.

Let's Move Salad Bars to California Schools

What is Let's Move Salad Bars to Schools?

A national movement is taking place to increase children's access and consumption of fresh fruit and vegetables by donating salad bars to schools nationwide. Known as "Let's Move Salad Bars to Schools," the initiative is working hard to end childhood obesity in a generation. School salad bars are a proven, effective strategy to increase kids' fruit and vegetable consumption and help them develop healthier eating habits. New nutrition standards double the amount of fruits and vegetables served in school lunches. Salad bars not only emphasize a colorful variety of fruits and vegetables, but are also the easiest way for schools to comply with nutrition standards.

The Centers for Disease Control and Prevention (CDC) is the lead federal agency for Let's Move Salad Bars to Schools. To date, more than 3,600 schools throughout the United States have received salad bars, benefitting millions of school children every day.

"Let's Move Salad Bars to Schools" is an initiative of the Food Family Farming Foundation, National Fruit and Vegetable Alliance, United Fresh Produce Association Foundation and Whole Foods Markets to support First Lady Michelle Obama's Let's Move! initiative.

How is the Silicon Valley Leadership Group Foundation supporting salad bars in California?

In support of State Superintendent of Public Instruction Tom Torlakson's "Team California for Healthy Kids" and the national "Let's Move Salad Bars to Schools" initiatives, the Silicon Valley Leadership Group Foundation, along with partner organizations and member companies, is working to raise money to provide Silicon Valley schools with salad bars.

The Silicon Valley Leadership Group Foundation partnered with Lam Research in 2014 to launch the Heart & Soles 5-K, which funds salad bars in Silicon Valley schools. The "Year One Goal" was to raise enough revenue to provide Salad Bars for 30 K-12 schools. Thanks to the generosity of more than 30 Silicon Valley Leadership Group member companies, and the participation of nearly 1,000 people in the Inaugural Heart & Soles 5K, that goal was nearly doubled. The Foundation was able to provide 56 salad bars to 53 public schools in Santa Clara, Santa Cruz and Alameda counties.

More than 36,000 K-12 students, most in underserved schools in economically poor neighborhoods, now have healthy choices presented in a visually appealing way each school day.

The 2nd Annual Heart & Soles 5-K is scheduled for February 7, 2015. With the dedication of member companies and community partners, the Silicon Valley Leadership Group Foundation is well on the way to achieving the ambitious 2015 goal of 60 additional salad bars, which would bring the two-year total to 116 salad bars.

What is the cost of a salad bar?

A salad bar, with shipping, costs \$2,825.

Who are the Primary Partners?

The primary partners are the San José Silicon Valley Chamber of Commerce, South Bay Labor Council, Santa Clara County Office of Education and member company Lam Research.


