SCHOOL CLIMATE AND SAFETY

POSITIVE LEARNING ENVIRONMENT

Mt. Pleasant High School's discipline policies are aligned with the East Side Union High School District's policies pertaining to student behavior. To ensure that our expectations are clearly delineated, a copy of the student/parent handbook is mailed to every home in the Mt. Pleasant High School attendance area at the beginning of each school year. We encourage parent and student conferences to correct student misbehavior and employ before school and after school detention, in-school suspension, and outof-school suspension as deterrents to continued misbehavior. In addition, Mt. Pleasant has reinstated a "No Fight Rule" which represents a zero tolerance for fighting. To ensure that all students are aware of the rules and are treated equitably, discipline charts were created and posted in every classroom. All District Policies, including the District's dress code and identification badge policies, are consistently enforced.

Because student achievement is a primary goal, Mt. Pleasant provides a wide variety of student resources. Students in need of academic support can find the help they need to succeed through the Morning Tutorial Sessions, Math Recovery Program, and After School Tutoring Program. In addition, the Cardinal Success Center offers additional services for students who are experiencing personal, social, and academic problems. To support the staff, we have embedded collaboration time into the weekly schedule so that teachers have the time they need to share best practices, examine student work, and participate in ongoing professional development opportunities.

DROPOUT RATE

Data reported regarding progress over the most recent three-year period toward reducing dropout rates include: grade 9-12 enrollment, the number of dropouts, and the one-year dropout rate listed in the California Basic Educational Data System (CBEDS). The formula for the one-year dropout rate is (Grades 9-12 Dropouts/Grades 9-12 Enrollment) multiplied by 100.

FACILITIES

Mt. Pleasant continues to undergo major renovations to its 36 year-old facility. Plans for a state-of-the-art theater, which will be used to accommodate both school and community needs, are in the process of being finalized. Moreover, there are plans to add 23 up-to-date classrooms so that the need for portables can be eliminated. In cooperation with the City of San Jose, the community, and the district, we have dramatically improved our outdoor facilities. Featuring an allweather track, lights, a concession stand, bathrooms, and increased parking, Mt. Pleasant boasts one of the best outdoor facilities in the Bay Area. As part of an ongoing effort to modernize the school, the quad areas have been landscaped, new tables and benches were added, and renovations are planned for all of the remaining buildings.

The maintenance staff does an excellent job of keeping the campus and classrooms clean, neat, and attractive.

SCHOOL DESCRIPTION

Mt. Pleasant High School prides itself on being a community of staff, students, and parents who collaborate to ensure success for all students. Working together, we produce graduates who not only have a sense of responsibility for themselves but also feel responsible for the welfare of their community. Mt. Pleasant specializes in providing real world experiences for students through academic support programs, such as AVID (Advancement Via Individual Determination). *Puente*, and through Academy programs such as: Animation, JROTC, Leadership, MIT (Manufacturing Industrial Technology), and Political Science/Communications. To increase the number of students who are prepared to undertake Advanced Placement classes, all subjects require students to meet "performance standards" through project-based learning components that are academically rigorous. As a result, Mt. Pleasant continues to add more AP classes each year. In addition to AP Calculus, AP Statistics, AP Art History, AP English, and AP Science classes, Mt. Pleasant added AP US History and AP Government to its course selections this year.

The school is making excellent progress to date. The school-wide Grade Point Average (GPA) is 2.46; the average daily attendance was 94.5% for the 2002-2003 school year; the dropout rate was reduced to less than 1%; and the number of Clubs on campus has increased to 42.

LEADERSHIP

Mt. Pleasant High School has continued its reputation for a high quality educational program for its students. But with the changing demographics of our population and the changing requirements for the workplace and our society, we have also realized that we must look carefully at our academic programs. It is important that we make every attempt to ensure that ALL students have an opportunity for success. To this end we have implemented four Tech Prep programs that integrate vocational and academic classes and prepare the students for the world of work or college. Our programs are in Manufacturing Technology (MIT Magnet), Political Science Academy, JROTC and Animation. Along with these efforts, we have established integrated curricular programs combining English and social studies on the 9th, 10th, and 11th grade levels. We have a Marine Junior ROTC program that serves over 100 students. The Mt. Pleasant AVID program has been a National Certified Demonstration School site for the past five years. Every year the AVID program graduates 100% of the seniors enrolled in AVID and 100% of these students attend college. All these efforts are an attempt to provide academic achievement and successful experiences for all students.
